PROMOTION OVERVIEW

- Members will receive Entry Tickets into the Draw (further details provided below on ways in which entry tickets are generated).
- The draw will take place on Saturday 30th March at 7.30pm
- Members are eligible to win more than once.
- Total prize pool is \$5,000
- There will be a total of 5 Draws conducted during the promotional period.

Draw

- The draw will take place on Saturday 30th Match 2024
- The draws will be conducted at 7:30pm
- Draws will include all tickets accumulated from 21st February to 7.00pm 30th march 2024

- Draw Procedure:
 - A ticket will be drawn from the Entry Barrel and will be announced on the PA system. The winner has 4 minutes to present themselves to the announcer.
 - If no winner is present at the time of the draw, a re-draw will occur until a winner is found

PROMOTION ENTRY

- Entry Tickets for the promotion will be issued to Members via the following ways:
 - With any \$30 or more purchase at the Café, \$15 or more purchase at the Bar. One ticket per eligible transaction, multiple tickets can be earned in each transaction and each day, so a \$60 Food spend will generate 2 x Entry Tickets.
- Entry tickets will cease generating at 7.00pm on Saturday, 30th March 2024.
- Members will be required to place their Entry Ticket into the designated Entry Barrel.
- Entry Tickets can be placed into the Entry Barrel at any time prior to the barrel being spun and up until the conclusion of a winner being found.

 - An Entry Ticket will be drawn from the Entry Barrel at the times listed above.
 - The Members Name & Membership Number will be announced over the Club's PA system.
 - The Member drawn will have 4 minutes to present themselves along with their 2018/2019 Financial Membership Card to the Promotional Staff Member conducting the Draw.
 - The Member will be ineligible if they are not on the Club's licensed premises at the time of their name being announced.

- If the Member drawn is not present, a redraw will occur at four (4) minute intervals until a winner is found
- Guests of the Club are not eligible to participate in the promotion.
- It is the responsibility of Members to be in an area of Glenbrook Panthers premise where they can hear draw announcements.
