

PANTHERS GLENBROOK MEMBERS CASH DRAW

TERMS & CONDITIONS

Authorised Under NSW Permit No. TP/00195

Conditions of Entry

The promotion is conducted by Glenbrook Panthers, under Penrith Rugby League Club Limited (ABN 57 000 578 398) herein referred to as "the club" of 1 Hare Street Glenbrook NSW 2773.

The '**\$10,000 MEMBERS CASH DRAW**' Promotion (the Promotion) commences at Friday 8th May 2026 and concludes on Friday, 7th May 2027.

Draws are held at the Panthers Glenbrook premises every Friday at **7.30pm and 8.30pm** (1 Hare Street, Glenbrook, NSW 2773).

- The promotion is open to current financial members of Panthers Glenbrook.
- The promotion comprises of a (1) Membership Badge Draw, (2) Second Chance Draw.
- The promotion operates in **rolling jackpot cycles**, where the prize starts at \$5,000, increases by \$1,000 each week if unclaimed, and must be won once it reaches \$10,000. Following a \$10,000 win, the jackpot resets to \$5,000 the following week.
- It is the responsibility of Members to be in an area of Panthers Glenbrook premises where they can hear the draw announcements.
- The Member will be ineligible if they are not on the Club's licensed premises at the time of the draw, that is if they are contacted after the initial draw and attend the Club to claim the prize.
- The member must personally present their full financial membership card or photo identification to the promotional host within four (4) minutes of the announcement to claim their prize.
- The member must have made at least one purchase on the day of the draw and swiped their membership card at the time of purchase to be eligible to win the cash prize.

(1) MEMBERSHIP BADGE DRAW

- A badge draw process will take place at the Panthers Glenbrook premises every Friday during the promotional period, whereby a Membership number is randomly selected from the Club Membership database using IGT. Members with the home club of "Glenbrook" only will be enrolled into the promotion.
- A draw will be conducted:
 - a. Friday: 7.30pm and 8:30pm
- All draws will be announced on the PA system at the Panthers Glenbrook premises. The winner has 4 minutes to claim their prize.
- The winner must have made at least one purchase and swiped their membership card through the point of sale terminal on the day of the draw (prior to the draw being announced) to be eligible to claim the prize. This will be verified through the IGT membership system.
- If a winner claims the cash prize at the time of any draw, then no further draw will take place until the following week.
- The jackpot pool starts at \$5000 and if the winner is not present, will jackpot by \$1000 each week. Once the draw reaches \$10,000 the entire amount must be won on that draw day and if a winner is not present at the 7.30pm or 8.30pm draw we will go to the Second Chance Barrel Draw (2b) to obtain these winners.

(2b) SECOND CHANCE DRAW - \$10,000 Jackpot

- Once the prize jackpot reaches \$10,000 and no Badge Draw winner is found there will be a Second Chance Draw (2b).
- Entry and draw procedure for Second Chance Draw are as follows –
- Second Chance Tickets for the Promotion will be issued to all Panthers Financial Members through the following ways:
 - With every \$30 spent at Flavours Café and for every \$15 spend at the Main Bar on Friday from 10.00am to midnight
 - Swiping Member's Membership Card (Glenbrook Home Club only) through the Swipe Kiosk.
 - The number of tickets generated will depend on the Panthers Member's tier level and will be as follows:
 - 1 Star members = 1 x ticket

- 2 Star members = 2 x ticket
- 3 Star members = 3 x ticket
- 4 Star members = 4 x ticket
- 5 Star members = 5 x ticket, Second Chance Entry Tickets will be issued during the following times:
 - Friday: 10.30am – 8.55pm
- The Entry Ticket(s) are valid for the 6-week duration of the draws if not won.
- The Entry Barrel for the Second Chance Draw will be available for Members to include their entry tickets into every Friday from 10.30am to 9.00pm.
- Members are not permitted to enter promotions on behalf of other Panthers Members.
- The winner must have made at least one purchase and swiped their membership card through the point of sale terminal on the day of the draw (prior to the draw being announced) to be eligible to claim the prize. This will be verified through the IGT membership system.
- A ticket will be drawn from the Second Chance Barrel and will be announced on the PA system at the Panthers Glenbrook premises. The winner has 4 minutes to claim their prize otherwise a re-draw will take place.
- It is the responsibility of Members to be in an area of Panthers Glenbrook premise where they can hear the draw announcements.
- The Member will be ineligible if they are not on the Club's licensed premises at the time of the draw, that is if they are contacted after the initial draw and attend the Club to claim the prize.
- We will draw five (5) members who will each win \$2,000.
- The members badge draw will recommence the following week at \$5,000

OTHER TERMS & CONDITIONS

- **If proposed prize money is greater than \$5000 the prize winner must be paid the amount exceeding \$5000 by a crossed cheque made out to the winner (or by EFT if the winner so requests). The full prize amount can be paid in this manner, if desired**
- Entrants acknowledge that the Promoter is not liable for reimbursement of any prizes otherwise payable to eligible entrants who are in violation of this provision.
- The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age, membership status and place of residence) and to disqualify any entrant whose entry is not in accordance with these Terms and Conditions or who tampers with the entry process. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
- If this promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law (a) to disqualify any entrant; or (b) subject to any written directions from a regulatory authority, to modify, suspend, terminate or cancel the promotion, as appropriate.
- Except for any liability that cannot be excluded by law, the Promoter (including its officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Promotion, including, but not limited to, where arising out of the following: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorized access or third party interference; (c) any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by a winner or entrant; or (f) use of a prize.
- The Promoter collects personal information in order to conduct the Promotion and may, for this purpose, disclose such information to third parties, including but not limited to agents, contractors, service providers, prize suppliers and, as required, to Australian regulatory authorities. Entry is conditional on providing this information. Entrants should direct any request to access, update or correct information to the Promoter. All entries become the property of the Promoter.
- If there is a dispute as to the identity of an entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the entrant.
- Panthers Directors, Employees, Contractors and their Employees including Social Members are not eligible to participate in the promotion.

- The rules pertaining to this promotion are binding, Club Managements decision in all matters relating to these rules and this promotion shall be final and no correspondence shall be entered into.
